### **STCW CONVENTION TRAINING COURSES**

The Director of Marine of the Hong Kong Special Administrative Region (HKSAR) hereby certified that the following courses conducted by the National Taiwan Ocean University, No. 2, Pei Ning Road, Keelung 20224, Taiwan are recognized by the HKSAR in compliance with the requirements of the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers 1978, as amended (STCW Convention). 12. Proficiency in Survival Craft and Rescue Boats
13. Ship Security Officer
14. Security Training for Seafarers with Designated Security Duties
15. Electronic Chart Display and Information System
16. Leadership and Bridge Resource Management
17. Leadership and Engine-room Resource Management
18. Marine Engineering (STCW Reg. III/1)
19. Maritime Studies (STCW Reg. II/1)
20. High Voltage Installation (HVI) Training

The recognition of the above STCW Convention courses will continue to be in effect subject to the satisfactory periodical verification conducted by the Marine Department within two and half years from the date of issue of this recognition and that the Director of Marine shall be notified of the changes to the syllabuses, curriculum or teaching staff etc. as they are made.
