RECOGNITION OF TRAINING COURSES FOR SEAFARERS CONDUCTED BY NATIONAL TAIWAN OCEAN UNIVERSITY (NTOU)

We are pleased to inform you that the Director of Marine has agreed to extend the recognition the courses, listed in Annex of this letter, conducted for seafarers by NTOU until **31 March 2025**, subject to the following conditions.

2. NTOU should :-

- a. conduct the courses based on the documents submitted. MPA is to be advised of any significant changes to the syllabi, curriculum or instructors;
- b. amend the course(s) materials to meet the new requirements recommended by MPA or IMO (e.g. guidance from HTW sub-committee, changes to model course, etc.) within a reasonable period;
- c. the conduct of courses shall be continuously monitored through a quality standards system in accordance to Regulation I/8 of the STCW Convention;
- make available to MPA (upon request) records of internal and external quality systems audits, assessments records, reviews of the course and related documents; and
- e. maintain records of the courses conducted, for 3 years the names of students, dates of courses held, results of assessments and course feedback from students.
- 3. MPA reserves the right to:-





- a. conduct regular and un-announced inspections of the premises and during the conduct of course and assessment in exercise of quality control;
- b. impose additional conditions for the conduct of the course; and
- c. withdraw the approval if any of the above conditions or requirements are not met or at any time after giving a written notice.
- 4. NTOU should have arrangements (e.g. email or internet access) to respond to MPA's queries on the status of such certificates issued within a reasonable time.
- 5. A review of the courses will be conducted prior to or on Oct 2025, prior to seeking of an extension of the recognition. Please provide us three months of advance notice for the extension of recognition.
